DEED OF GUARDIAN.

This Indenture made and entered into this 23 day of November, 1909, by and between Eugene E. Tipton, the duly appointed, qualified and acting guardian of Laura Tipton, a minor, party of the first part, and H.B. Boyd, party of the second part.

WITNESSETH: That whereas, on the 24th day of September 1909, the County Court within and for Oherokee County, State of Oklahoma, made and order of sale authorizing the said party of the first part to sell certain real estate of said Laura Tipton, a minor, said lands being situated in the County of Tulsa, State of Oklahoma, and specified and particularly described in said order of sale, either in one parcel of in separate parcels, as said party of the first part should judge most beneficial to said estate, and which said order, now on file and of record in said County Court, is hereby referred to and made a part of this indenture; and
