nor allow any intoxicating liquors to be sold or given away for an, such purposes on such premises; that he will not use such premises for any other purposes than those authorized in this lease, and that before abandoning any well he will securely plug the same so as to effectually shut off all water above the oil bearing horizon.

And the said party of the second part further covenants and agrees that he will keep and accurate account of all oil-mining operations, showing the sales, price, dates, purchasers, and all thewhole amount of oil mined or removed; and all sums due as a royalty shall be a lienon all implements, tools, movable machinery, and all other personal chattels used in said prospecting and mining operations, and upon all of the unsold oil obtained from the land herein leased as security for the payment of said royalty. This lease shall be of no validity until approved by the County Court of Creek County, Oklahoma. And no assignment of this lease shall be of any validity without the approval of said Court. It is agreed that the Bonus and all Rentals and Royalties hereunder are to be paid to the County Court of Creek County, Oklahoma, for said Guardian.
