said sum the highest and best sum bid; that said sale was legally, and fairly conducted; that the said sum is not disproportionate to the value of the property fold and that a sum exceeding such bid at least ten per cent, exclusive of the cost of a new sale cannot be obtained, and that the said W.E. Chambers, Guardian in all things proceeded, conducted and managed such sale as required by the statute in such case made and provided, and as by said order of court required and directed. It is therefore,

ORDERED, ADJUDGED AND DECREED by the court that the said sale be and the same is hereby confirmed and approved and declared valid, and the said W.E. Chambers, Guardian as aforesaid, is hereby directed and authorized to execute to said purchaser proper and legal deed or deeds of conveyance of said real estate.
