OIL AND GAS MINING LEASE UPON LANDS SELECTED FOR ALLOTMENT CREEK NATION
INDIAN TERRITORY.

(Sec. 18 Act of June 30, 1902, 32 Stat. 500)

THIS INDENTURE OF LEASE, Made and entered into in quadruplicate on this 6th day of April A.D. 1907 by and between E.L. Cooper, guardian of Stella Cooper, a minor, of Broken Arrow, Ind. Ter. part-- of the first part, lessor, and Minshall Oil and Gas Company, a corporation organized under the laws of West Virginia, of Tulsa, Ind. Ter. party of the second part, lessee, under and in pursuance of the provisions of section 17 of the act of Congress approved June 30, 1902, and the regulations prescribed by the Secretary of the Interior thereunder.

WITNESSETH, that the party of the first part, for and in consideration of the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed by the party of the second part, its heirs, successors, and assigns, do hereby demise, grant, and let unto the party
