Order approving Lease.

Now on this 16th day of December, 1909, the same being one of the regular judicial days of this term of Court, comes Herbert E. Woodward guardian of the person and estate of Hazel D. Woodward, minor and presents herein his petition asking for leave to lease the land of said ward for oil and gas mining purposes, described as follows, to-wit:

The Southeast quarter of Section Eighteen (18) Township Nineteen (19) North, Range Thirteen (13) East in Tulsa County, Oklahoma; and on this day filed his report herein showing that said guardian has leased the land of said ward described above for oil and gas mining purposes to C.L. Mullen of Tulsa, Oklahoma, for a period of 6 yrs 2 mos. years for a bonus of \$160.00 and 1/8 royalty on the production of said lease and \$200.00 annually for each gas well used, during the term of said lease; and the court having examined said petition, files and exhibits, and having heard the testimony of the witnesses on behalf of the petition, and the court having examined said report of leasing said land for oil and gas mining purposes to said C.L. Mullen, of Tulsa, Oklahoma, and the court being fully advised in the premises.

It is therefore, ordered, adjudged and decreed by the Court that the prayer of said petition be and the same is hereby allowed; and the report of leasing of said ward's land is hereby approved, and said guardian is hereby authorized and directed to turn over said lease to the said C.L. Mullen upon the payment of said bonus.
