ORDER APPROVING OIL AND GAS LEASES.

Davis to approve an oil and gas lease made by him as guardian on the North-west quarter of Section Twenty-six (26) township Nineteen (19) north, range thirteen (13) East in Tulsa County, Oklahoma, the property of Clifford Davis, a minor; also to approve an oil and gas lease made by him as guardian on the south-west quarter of section twenty-six (26) township nineteen (19) north, range thirteen (13) East in Tulsa County, Oklahoma, the property of Rosie Davis, a minor; and also for approval of an oil and gas lease made by him as guardian on the north-east quarter of section twenty-six (26) township nineteen (19) north, range thirteen (13) East, the property of Herbert Davis, a minor; all of said leases being made to A.T.
