Allotment Deed. 4712 (77) THE CHEROKEE NATION, Indian Territory? TO ALL TO THOM THESE PRESENTS SHALL COME GREETING:

Whereas, by act of Congress approved July 1, 1902, (32 State716) ratified by the Cherokee Nation August 7, 1902, it is provided that there shall be allotted by the Commission to the Five Civilized fribes, to each citizen of the Cherokee Tribe, land equal in value to one hundred and ten acres of the average allottable lands or the Cherokee Dation, and.

WHEREAS, it was provided by said act of Congress that each citizen shall designate or have designated and selected for him at the time of his selection of allotment, out of his allotment, as a homestead, land equal in value to forty acres of the average allottable lands of the Cherokee Nation, as nearly as may be, for which he shall receive a separate certificate, and,

Thereas, The said Commission to the Five Civilized Tribes has certified that the land hereinafter described has been selected by or on behalf of James F. Tyner, Jr. a citizen of said tribe, as an allotment, exclusive of land equal in value to forty acres of the average allottable lands of the Cherokee Nation, selected as a homestead as aroresaid.

Now, Therefore, I, the undersigned Frincipal Chief or the Cherokee Nation, by virtue of the power and authority vested in me by aforesuid met of the Congress of the United States, have granted and conveyed and by these presents do grant and convey unto the said J.F. Tyner Jr. all right, title, and interest of the Cherokee Nation, and of all other citizens of suid Mation, in and to the following described land, viz: The South East Quarter of the South West Quarter of the North East Quarter and the Morth Half of the South West Quarter of the North East Quarter and Lot One (1) and the North Half of the North West Quarter of the Morth East Quarter of Cection Twenty six (26) Township Twenty-one (21) North and Hange Twelve (12) East of the Indian Base and meridian in Indian Territory, containing Fifty seven and 64/100 457.64) acres, more or less, as the case may be, according to the United States survey thereof, subject, however, to all the provisions of said Act of Congress.

IN VILLESS WHEREOF, I, the Principal "hief of the Cherokee Nation have hereunto set my hand and caused the Great Seal of Said Nation to be affixed this 24th day of February A.D. 1905.
