And the said party or the second part expressly agrees that should it, or its sublessees, heirs, executors, administrators, successors, or assigns, violate any of the covenants stipulations or provisions or t is lease or rail for the erior of sixty days to the stipulated monthly royalty provided for herein, then the party of the first part shall be at liberty in his discretion, to avoid this indenture or lease and cause the same to be annulled, when all the rights, tranchises, and privileges of the party or the second part its sublessees, heirs, executors, administrators, successors, or assings, hereunder shall cease and end without rurther proceedings.

If the lessee makes reasonable and pona fide effort to find and produce oil in paying quantity asis herein required of it, and such errort is unsuccessful, ir my at any time thereafter, with the approval of the Secretary of the Interior, surrender and wholly terminate this lease upon the full rement and performance of all its then existing obligations, Provided, however, That approval of such surrender by the Secretary will be required only during the time his approval of the alienation or the land is required by Law.

It is further agreed and understood that this lease shall be of no forc or effect unless the party of the second part shall, within sixty days from the date of approval or the application filed in connection herewith, furnish a satisfactory bond in accordance with the regulations of March 20, 1905, prescribed by the Sectetary or the Interior, which shall be apposited and remain in the Indian Office during the life of this lease.
