RELEASE OF MORTGAGE.

THIS INDENTURE, made this 28th day of December A.D. 1909, between B.H. Redecker, of the City of Rock Island, County of Rock Island and State of Illinois, party of the first part, and Lynde-Bowman-Darby Company, incorporated, of Muskogee, Oklahoma, party of the second part, WITNESSETH:

WHEREAS, said Lynde-Bowman-Darby Company, by a mortgage bearing date the 3rd day of February A.D. 1908 and recorded in the office of the Register of Deeds, in and for Tulsa County, Oklahoma, on February 8th, 1908, in Book 31 Records, at page 345 thereof, for the consideration therein mentioned and to secure the payment of the money therein specified, did convey certain lands and tenements, of which the premises hereinafter described are part, unto said B. H. Redecker;-

AND WHEREAS, the said party of the first part, at the request of the said party of the second part, has agreed to give up and surrender the premises hereinafter described unto said party of the second part, and to hold and retain the residue of the mortgaged premises as security for the money remaining due on said mortgage;-

Now This Indenture Witnesseth; that said party of the first part, in pursuance of said agreement and in consideration of the sum of Sixteen Hundred and Seventy Two 50/100 (\$1672.50) Dollars to him paid, the receipt whereof is hereby acknowledged, have Granted, Remised, Released, quit Claimed and set over and by these presents does Grant, Remise, Release, quit claim and set over unto said party of the second part, all that part of said mortgaged premises known and described as the North Half of the South East Quarter of Section Twenty Six (26), Township Number Nineteen (19) North, Range Fourteen (14) East in Tulsa County, Oklahoma;-
