THIS INDENTURE OF LEASE, made and entered into in quadruplicate on this 20th day of April A.D. 1905 by and between Henry V. Wilkey Curator of Alberta West a minor John Courtney McGehee, of Claremore, Indian Territory, party of the first part, and Penn Oil Company, a corporation organized and existing under and by virtue of the laws of the United States in force in the Indian Territory, of Bartlesville, Indian Territory, party of the second part, under and in pursuance of the provisions of section 72 of the Act of Congress approved July 1, 1902, and the regulations prescribed by the Secretary of the Interior theretofore.
