It is further ... read and understood that this leave shall be of no force or effect unless the party of the second part chall, within sinty days from the date of approval of the application filed in connection here ith furnish a satisfactory bond in ascord neo with the regulations of March 20, 1905, prescribed by the Secretary of the Interior, thich shall be deposited and remain on file in the Indian office during the life on this lease.
