AGREEMENT.

THIS AGREEMENT, Made and entered into this the 10th, day of April 1909, by and between the Ryan Oil and Gas Company, a corporation and the Frick-Ried Supply Company, a corporation

WITNESSETH: That Whereas, the Ryan Oil and Gas Company, are the owners of an oil and gas lease made and executed by James H. Thomas, as Guardian of Viola B. Thomas, George H. Thomas, Orville W. Thomas, Theron T. Thomas and Gladys M. Thomas, and covers the following described lands, to-wit:

The S $\frac{1}{2}$ of SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 24, Township 20, Range 12 East, in Tulsa County Oklahoma, for a term of five years from the 28th, day of August 1908.

And whereas the Ryan Oil and Gas Company, to obtain Twenty Five Hundred Dollars worth of Oil and Gas well supplies from the said Frick-Ried Supply Company, has this day assigned the above described oil and gas lease to the said Frick-Ried Supply Company as security for the payment of said sum of twenty Five Hundred Dollars.

It is therefore agreed by and between both parties hereto that the Ryan Oil and Gas Company agree to have the pipe line to which the oil is sold off of said lease pay to Frick - Reid Supply Company 31 $\frac{1}{4}$ % of the proceeds of the sales of the oil produced and sold from said lease until the Frick -Ried Supply Company have received the said sum of Twenty Five Hundred Dollars.

If said 31 $\frac{1}{4}$ % of the proceeds of the sales of said oil as aforesaid does not amount to enough money to pay to the said Frick-Ried Supply Company the said amount of Twenty Five Hundred Dollars, within six months from the date hereof, then the said assignment as above described shall become absolute and the Frick-Ried Supply Company shall become the absolute owners of said lease. To the extent of the amount still due them from the Ryan Oil and Gas Company.
