Now, on this 19th, day of May 1909, comes Isalah Steele, Guardian of the Estate of Willie Steele and Sallie Steele, Minors, and shows to the Court, that it will be for the best interests of said minors to make certain improvements upon the lands now occupied by said minors, and the court being fully advised in the premises, finds it is necessary and for the best interests of said minors, that a mortgage be placed on said land for the sum of Two Hundred (\$200.00) Dollars, for improvements thereon.

WHEREFORE, it is hereby ordered, adjudged and decreed that the said Isalah Steele, as guardian of said minors, Willie Steele and Sallie Steele, be and is hereby ordered and directed to place a mortgage on said land in the sum of Two Hundred (\$200.00) Dollars, at 8% interest, for a term not to exceed three years, and that the said Isalah Steele Guardian, shall execute said mortgage and promissory note in accordance therewith, and that the said shall be a valid lien and claim upon the Forty (40) acres of land herein described, as belonging to the said Willie Steele and Sallie Steele, minors, to-wit:

The Southeast Quarter of the Southwest Quarter of Section 13, Township 19 North, Range 13 East, Tulsa County, Oklahoma, being in all forty acres, together with the improvements thereon.
