WITNESSETH: That for and in consideration of the sum of \$750.00, the receipt of which is hereby acknowledged, the said Latimer and Harnage agree to sell and convey to Minerva E. Latimer, the following described real estate,

Lots 5 and 6, in Block 6 in the Burgess Hill Addition to the City of Tulsa, Indian Territory, upon the following conditions, to-wit:

That as soon as the Union Trust Company, party Trustee for said Latimer and Harnage, have been fully satisfied in its claim against said Burgess Hill Addition, in the sum of \$1500.00 out of the sales of the first lots, then the said Latimer and Harnage agree to procure a good and sufficient warranty deed from the said Trustee to the said Minerva E. Latimer, without any further or additional consideration than that mentioned above.

The said Latimer and Harnage, for the consideration above mentioned agree and bind themselves to secure the deed to the aforesaid lots, and to protect the title in said lots
