the Interior; which removal of restrictions was recorded in Book P, at page 376 in the office of the Deputy U. S. Clerk, at Sapulpa, Indian Territory; said removal of restrictions is dated June 30th, 1905.

That I caused the Northwest Quarter of the Southeast Quarter of the Northwest Quarter of Section Twelve, Township Nineteen North, Range Twelve East to be platted into Lots and Blocks, and to be known as the Horner Addition; which plat was filed June 29th 1907 and recorded in Book 12 at Page 639 in the office of the Deputy U. S. Clerk at Tulsa Indian Territory.

That I later by Warranty Deed conveyed to L. K. Cone the following described land, to-wit:

The South Thirty Feet of Lot One (1), all of Lots Two (2), Three (3) Four (4) Five (5) and Six (6) in Block Six (6) of the Horner Addition to Tulsa, Oklahoma, according to the official survey and recorded plat thereof. Said deed being recorded Book 25, Page 602, Register of Deeds Office, Tulsa, Okla., Tulsa County.

That in each of the proceedings and instruments named above, and in fact in all instruments in the course of the title of said land and property, Ella Harner and Ella Horner are one and the same persons, and I am that person.

I further state that in a certain action in the District Court of Tulsa County, in the State of Oklahoma, entitled Ella Horner, Plaintiff vs. Mike Horner, Defendant, wherein Decree was rendered November 17th, 1908, I am the Plaintiff therein named, and at the time of the execution of said deed to L. K. Cone, recorded in Book 45, at page 602, Register of Deeds Office, at Tulsa, Oklahoma, Said Mike Horner was my husband.
