The East Half $(\frac{1}{2})$ of the Southwest Quarter $(\frac{1}{4})$ of Section 13, Township 19 North, Range 10 East, Tulsa County, Oklahoma. Together with the tenements, hereditaments and appurtenances whatsoever to the same belonging or in anywise appertaining.

TO HAVE AND TO HOLD, all and singular the above mentioned and described premises, unto the said party of the second part, his heirs and assigns forever.
