I, James Chambers, being first duly sworn, on oath do say that I am a Cherokee Indian Citizen, and duly enrolled on the rolls of said tribe as allottee No. 28802, and to whom was allotted the North Fifty acres of the North Half of the Northwest Quurter of Section 17, Township 21 , Range 14 Cherokee Nation. That I gave a warranty deed to said premises some time ago to one W. A. Crosby of Muskogee to said land, but said deed was given during my minority and he took said deed to hold until I became of age, when he was to buy said land if I then chose to sell it to him. I was at that time indebted to him in the sum of \$100.00 and am still owing him that amount. That I have never since given him any deed to said land and have concluded not to sell the land to him. That some time ago I gave a deed to Mr. J. Z. Smith for saidland, Mr. Smith paying me som/money down at the time with the understanding that I was to obtain the balance of the agreed purchase price upon my executing another deed upon my reaching my majority. That on September 23rd, 1907, I gave Mr. Smith another deed for said land and received the balance of the purchase price for said land in full and I am fully satisfied withthe transaction and have no further claims uppn Mr. Smith for said purchase price whatsoever. That I was born on the 22nd day of September 1886 and was, therefore on the 23rd, day of September 1907 one day over 21 years of age. That I am single and unmarried, and that the restrictions upon the sale of my surplus land were removed by the Secretary of the Interior on September 4th, 1906. Witness my hand this 24th, day of September 1907.
