NOW, pursuant to the order heretofore made herein on the 13th, day of April 1909 on this the 30th, day of April 1909, the court being duly assembled with the Clerk and Sheriff in attendance, and this day being a regular day of he April Term 1909 of this Court, there coming on for hearing the return of sale of real estate made by Jim Ceasar as the guardian of the estate of Ellen Owens, a minor, herein; said return of real estate being filed herein on the 13th, day of April 1909, and said Jim Ceasar appearing in person and by his attorney, William B.
