royalty one eighth part of any oil that may be obtained, and One Hundred (\$100.00) Dollars for each well where gas is obtained from said wells in paying quantities and marketed from said wells.

NOW THEREFORE/ it is ordered, adjudged and decreed that the said Frank McClaif, as guardian of Charlie McClaif, John McClaif and Mack McClaif, minors, is hereby authorized, empowered and directed forthwith to execute to the said Colorado Oil Company, an oil and gas mining lease covering the above described lands of the above mentioned Charlie McClaif John McClaif and Mack McClaif, minors, said lease to run for a term of Fifteen (15) years, said term of years not to exceed the minority of said minors and as much longer as oil or gas is found in paying quantities upon the terms and conditions in this order set forth.
