DEED OF GUARDIAN.

THIS INDENTURE, Made this 31st, day of May 1909, by and between Charles W. Mandler the duly appointed, qualified and acting guardian of Sid Kernal, a minor, party of the first part, and Walter Mitchell, party of the second part.
