LEASE CONTRACT.

WITNESSETH: That for and in consideration of the covenants and agreements hereinafter made and set forth, the party of the first part has let, leased and demised and does by these presents let, lease and demise unto the party of the second part, his heirs and assigns for agricultural purposes, for the term of One year from and after the first day of Jan. 1910, the following described tract of land, to-wit:

NW. 1/4 Section 28, Township 17 North, Range 13 East, amounting to 160 acres, more or less and being the individual allotment of Walter Berryhill, minor child of party of first part.
