OIL AND GAS MINING LEASE. UPON LAND SELECTED FOR ALLOTMENT, CHEROKEE NATION, INDIAN TERRITORY. (CECTION 72, Act of July 1,1902,32 Stat., 716,726

of January A. D., 1906, by and between Sylvester Summer of Ft. Gibson, Indian Territory party of the first part, and Owasso Oil Company, a corporation organized and existing under the laws of the State of Deleware, of Blairsville, Pa., party of the second part, under and in pursuance of the provisions of Section 72 of the Act of Congress approved July 1, 19042, and the regulations prescribed my the Escretary of the Int. rior thereunder.

WITNESSETH: That the party of the first part, for and in consideration of the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed by the party of the second part, its successors and assigns, does hereby demise, grant and let unto the party of the second part, its successors and assigns for the term of fifteen years from the datehereof all of the oil deposits and natural gas in or under the following described tract of land, lying and being within the Cherokee Indian Nation and within the Indian Territory, to-wit:

The SE/4 of the NE/4 of Section Fourteen (14), Township Twenty One (21) North, Range Thirteen (13) East, of the Indian Meridian, and containing forty (40) acres, more or less, with the right to prospect for, extract, pipe, store, refine and remove such cil and natural gas/ and to occupy and use so much only of the surface of said land as may be reasonably necessary to carry on the work of prospecting for, extracting, piping storing, refining and removing such oil and natural gas, including also the right to obtain from wells or other sources onsdid land, by means of pipe lines or otherwise a sufficient supply of water to carry on said pperations, and inclusing still further the right to use such oil and natural gas as fuel so far as it is necessary to the prosecution of said operations.

In consideration of which the saidparty of the second part hereby agrees and binds itself, its successors and assigns, to pay or cause to be paid to the lessor as royalty the sum of ten per cent of the value, on the leased premises, of all crude oil extracted from the said land, and if the parties do not before the tenth day of the month succeeding its extraction, agree upon the value of the crude oil on the leased premises, the value thereof shall be finally determined under the direction of the Secretary of the Interior in such manner as he shall prescribe, and to so pay the royalty accruing for any month on or before the twentyfifth day of the month succeeding; and where the value of the crude oil fluctuates, the average value during the month shall constitute the criterin in Computing the revalty; and to pay in yearly payments, a t the end of each year, one hundred and fifty Dollars royalty on each gas-producing Well, the lessor to have free the use of gas for lighting and warming his residence on thepremises. But failure on the part of the lessee to use a gas-producing well, where the same cannot be reasonably utilized at the rate so prescribed, shall not work a forfeiture of this lease so far as the same relates to mining oil, but of the lessee desires to retain gas producing privileges he shall pay a royalty of 50 collars per annum on each gas producing well not utilized, the first payment to become due and to be made within thirty days from the date of the discovery of gas, payments thereafter for such wells to ne made in advance at the first of each succeesing year, dating from first payment.

And the party of the secondpart further agrees andbinds itself, its successors and assigns, to pay or cause to be paid to the lessor, as advanced annual royalty on this lease
