OIL AND GAS LEASE.

Made this 4th, days of June A. D. 1909, between Alex S. Lewis and Elizabeth P. Lewis, his wife of Dawson, Tulsa County and State of Oklahoma, Lessors, and John Eaton of Pittsburgh Pa. Lessee.

WITNESSETH: That the Lessors, in consideration of One Dollar, the receipt of which is hereby acknowledged, and the agreements hereinafter contained and to be kept and performed by the Lessee, does hereby grant unto the lessee, his heirs and assigns all the Oil and Gas in and under the following described tract of land for the sole purpose and with the exclusive right of operation thereon for oil and gas, together with the right of way over and across said premises to all places of operation, by said lessee lying adjacent thereto, the right to erect derricks and all other necessary buildings, lay pipes over and across said premises, and to use water, gas or oil to run the necessary machinery; also the right to remove at any time any property placed thereon by Lessee which said tract of land is sitiated in Tulsa County and State of Oklahoma, and described as follows to-wit:

The N½ NE½ of Section No. 27, Twp. No. 20, Range 13 E. I. M. SE½ of SW½ SE½ of Section No. 22, Township No. 20 Range No. 13 E. I. M. SW½ pf SW½ of Section No. 22 Twp 20, Range 13 E. I. M. NE½ OF NE½ of Section No. 28, Township No. 20, pange No. 13 E. I. M. NE½ of NE½ of Sec. No. 22 Twp. 20, Range 13 E. I. M., containing 180 acres more or less.

TO HAVE AND TO HOLD THE SAME UNTO THE LESSEE HIS HEIRS AND ASSIGNS? FOR THE TERM of (5) five years from the date hereof, and as much longer as oil or gas is found in paying quantities thereon; yielding and paying to the lessor the one eighth (1/8) part of all the oil produced and saved from the premises, delivered free of expense into tanks or pipe limes to the lessors credit, and should any well produce gas in sufficient quantities to justify marketing, the lessor shall be paid at the rate of One Hundred Fif ty Dollars (\$150.00) per year for such well so long as gas therefoom is sold and lessor is to have gas for domestic use in one dwelling house on the premises free of cost, they making their own connections.
