laying pipe lines, constructing tanks, buildings and other structures thereon to take care of said products, all that certain tract of land situated in the County of Tulsa, State of Oklahoma, bounded and described as follows, to-wit:

It is agreed that this lease shall remain in force for a term of years, expiring at majority, to-wit: Jan. 23" 1922, and as long thereafter as oil or gas, or either of t them is produced therefrom by the party of the second part, its heirs, successors or assigns.

: In consideration of the premises, the said party of the second part covenants and agrees:

1. To deliver to the credit of the first party, her heirs or assigns, free of cost into the pipe lines to which lessee may connect oil wells, the equal 1/8 part of all oil produced and saved from the leases premises.

2.To pay to the first party One Hundred Fifty (\$150.00) Dollars each year in advance for the gas from each well where gas only is found, while the same is being sold off the premises; and the first party to have gas free of cost to heat and light one dwelling house on that premises during the same time.

3. The party of the second part agrees to commence drilling operations on the above described premises within one year from date hereof, or pay at the rate of One Dollar per acre for each additional year such commencement is delayed from the time above mentioned.

The above rental shall be paid to the credit of the first party at Central Nat'l. Bank Tulsa Oklahoma, and it is agreed that the completion of such well shall be and operate as a full liquidation of all rent under this provision during the remainder of the term of this lease.

The party of the second part shall have te right to use oil, gas and water produced on said land, free of royalty, for drilling and operation thereon, execpt water from wells of first party.

The party of the second part shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing.

The party of the second part, heirs, successors or assigns, shall have the right at any time on the payment of One '\$1.00) Dollar and all payable obligations then due to the party of the first part, her heirs or assigns, to surrender this lease for cancellation, after which all payments and liabilities hereafter to accrue under and by virtue of its terms shall cease and determine.

Second party further agrees to pay first party t e further sum of One Dollar per year as rental for the above described land, providing the royalty hereon does not exceed that amount.

All covenants and agreements herein set forth, between the parties hereto shall extend to their successors, heirs, executors, administrators and assigns.
