exclusive owner of said real estate.

IT IB FURTHER ORDERED, ADJUBGED AND DECREED that the plaintiff's title to said real estate be quitclaimed against any adverse claim of the defendants or either of them. IT IS further ordered, adjudged and decreed that the plaintiff pay the costs.
