QUIT' CLAIM DEED.

WITNESSETH: That the said party of the first part, in consideration of the sum of One Dollars, the receipt whereof is hereby acknowledged, has remised, released, conveyed and quitclaimed, and by these presents does quit claim unto said party of the second part, his heirs and assigns, all our right, title, interest, estate, claim and demand both at law and in equity in and to all of the following described real estate, situate in the County of Tulsa, and State of Oklahoma, to-wit:

The West Half of the Southeast Quarter and the Southeast Quarter of the Southeast Quarter of Section Fourteen (14) Township Nineteen (19) North, Range Thirteen (13) East of the Indian Base and Meridian, according to the U. S. Government Survey thereof. Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging:

TO HAVE AND TO HOLD the above described premises unto the said T. D. Harris, his heirs and assigns; so that neither the said D. A. Skillen and L. R. Skillen, nor any person in their names and behalf shall or will hereafter claim or demand any right or title to the said premises or any part thereof, but they and every one of them shall by these presents be excluded and forever barred.
