

VENDOR'S LIEN.

KNOW ALL MEN BY THESE PRESENTS:

THIS INDENTURE: Made this 8th, day of June A. D., 1909, by and between the Gypsy Oil Company, a corporation, of Oklahoma, party of the first part, and the *Shelby* Oil and Gas Company, a corporation, party of the second part:-

WITNESSETH:- That Whereas, the said *Shelby* Oil and Gas Company, has heretofore obtained Oil and Gas leases on lands hereinafter described, as follows, to-wit:

1.

Lease dated the 13th, day of December 1905, by Electa J. Ralston, on the NW/4 of the NW/4 of Section 10, Township 17 N., Range 12 East, Tulsa County, Oklahoma. On which said land the *Shelby* Oil and Gas Company has drilled Seven (7) wells for oil and equipped the same with casing, tubing, rods, etc., and has placed thereon tanks, boilers, engines, and other material used in operating said premises.

2.

Lease executed by Allen W. Ralston and wife on the 25th, day of November 1905, on the SW/4 of SW/4 of Section 3, Township 17, Range 12 E., Tulsa County, Oklahoma, and also the SE/2 of the SE/4 of SE/4 of Section 4, Township 17, Range 12 E., Creek County, Oklahoma, and on which said lands said *Shelby* Oil and Gas Company, have drilled Seven (7) Wells for oil and equipped the same with casing, tubing, rods, etc., and located thereon power houses, house, stable, tanks, pumping power complete, and other material machinery and appliances used on said lease, and connected therewith in operating same.

Lease executed by George Brown unto the *Shelby* Oil and Gas Company, dated the 9th, day of March 1906, on the SE/4 of the NE/4 of Section 4, Township 17, Range 12 East, Creek County, Oklahoma, and on which said land, the *Shelby* Oil and Gas Company have drilled Two Wells for oil and equipped the same fully, with casing, tubing, rods, etc., and have located thereon, boilers, engines, power house, tanks and material, appliances, machinery used on said lease and connected therewith.

Lease executed by William Anderson, Guardian of Lucy Brown and Nellie Brown, heirs of Lalley Brown, deceased, to the *Shelby* Oil and Gas Company, dated the 13th, day of September 1906, on the W/2 of the NW/4 of Section 34, Township 18, Range 12 E. Tulsa Co., Okla., and said *Shelby* Oil and Gas Company have drilled on said land, eleven (11) wells, and equipped the same, and has placed on said land boilers, engine house, engine and other material machinery & appliances used in operating said lease, and connected therewith.

✓ Lease assigned by the Barnes Oil Company, to the *Shelby* Oil and Gas Company, on land owned by Rachel Perryman, said assignment being dated the 11th, day of June 1907, and duly approved by the Secretary of the Interior on September 6th, 1907, on land described as the SW/4 of Section 27, Township 18 Range 12 East, Tulsa County, Oklahoma, on which said land said *Shelby* Oil and Gas Company has drilled Three (3) wells for oil and equipped the same, and have located thereon tanks and all machinery material and appliances used in operating said lease.

Lease executed by Henry W. Perryman, Guardian of Joseph Perryman, a minor, to said *Shelby* Oil and Gas Company on the 14th, day of June 1906, on the NW/4 of Section 27, Township 18, Range 12 East, Tulsa County Oklahoma, No wells have been drilled on said land.
