

DEDICATION DEED.

THIS INDENTURE, Made this the 12th, day of May, in the year A.D., 1909, by S. F. Jones and Minnie Jones, his wife; M. B. Shutts and Liddie M. Shutts, his wife and Thomas J. Dawson and Lena L. Dawson, his wife, to the public.

WITNESSETH: That whereas, the parties of the first part are the owners in Fee of the lands hereinafter described; and whereas, the said lands, the

Southwest Quarter of Section 18, Township 19 North, Range 13 East, Tulsa County, Oklahoma, now being owned by the above named parties, and that it is necessary and more convenient in the division and ownership of said lands to subdivide same and provide roadways, the said S. F. Jones and Minnie Jones, his wife, M. B. Shutts and Liddie M. Shutts, his wife and Thomas J. Dawson and Lena L. Dawson, his wife, do by these presents give, grant and convey the following described portion of said above described land to be used as and for a roadway to the public, to be used by the public ~~as~~ according to the law in usage for public highways; said roadway or roadways is described as follows: Beginning at a point 1305 Thirteen hundred and Five feet north of the Southwest corner of Section 18, Township 19 North, Range Thirteen East in said Tulsa County, Oklahoma. Thence East Thirteen hundred and Five feet; Thence South Six Hundred and Forty five feet. Thence East Thirty Feet; Thence North Nineteen hundred and Eighty feet; Thence West thirty Feet; Thence South Thirteen Hundred and Five feet; Thence West (1305) Thirteen Hundred and Five feet; Thence South Thirty Feet to the place of beginning.

To be held and used, the above granted premises, for road and highway purposes, according to the laws of the State of Oklahoma.
