TRUST DEED.

THIS INDENTURE, Made this 17th, day of June 1909, by and between W. P. Moore and Anna E. Moore (husband and wife) E. Milton Latimer and Minerva E. Latimer (husband and wife) and J. L. Harnage and Veronica Harnage (husband and wife), all of the City of Tulsa, Tulsa County, Oklahoma, hereinafter known as parties grantor, herein, and the Union Trust Company, a corporation, of Tulsa, Tulsa County, Oklahoma, hereinafter known as party Trustee.

WITNESSETH: That the parties grantor, being the owners of the land hereinafter described, for and in consideration of One Dollar (\$1.00), the receipt of which is hereby acknowledged, and for other good and valuable considerations, and to facilitate the making of conveyances to purchasers, do by these presents, grant, bargain, sell and convey unto the Union Trust Company, as Trustee, and unto its Successors and assigns, forever, the following described real property and premises, to-wit:

All of Lot Seven in Section Thirty Five (35), Township Twenty (20) North of Range Twelve (12) East, which has been surveyed and platted into an addition to the City Of Tulsa, designated and known as the Burgess Hill Addition, more particularly described as follows:
