

AGRICULTURAL LEASE.

THIS LEASE, Made and entered into this 9th, day of June 1909, by and between Sam McKellop, Guardian of Martha McKellop, of Red Bird, Oklahoma, hereinafter called the lessor, and W. S. Bailey, of Broken Arrow, Okla., Oklahoma, hereinafter called the lessee:

WITNESSETH: 1. That the lessor is the Guardian of the owner of the following described real estate and premises, situate in Tulsa County, Oklahoma, to-wit:

Southwest Quarter of Section 23, Township 19 North and Range 14 East..

2. That the lessor in consideration of the covenants, promises and agreements herein contained and expressed, hereby rents, leases and lets to the lessee the above described premises. TO HAVE AND TO HOLD the same from the 1st, day of January 1910, to the 1st day of January 1915, together with the buildings and improvements thereon, for agricultural purposes.

3. That the lessor covenants to place the lessee in the quiet and peaceable possession of said premises on or before the beginning of the term covered by this lease, and to protect the lessee in the quiet and peaceable possession of said premises during the life of this lease.

4. That the lessee promises and agrees to pay to the lessor as rental for said premises for said term, the sum of Four Hundred Dollars, payable as follows: \$80.00 cash; \$80 on approval; \$80 Jan. 1st, 1912; \$80.00 Mar. 1st, 1913; \$80 Jan. 1st, 1914.

5. That no part of said rent money shall be due and payable until the lessee shall have been placed in the quiet and actual possession of said premises, except as noted.
