BE IT REMEMBERED, that on this the 8th, day of April 1909, at the regular term of the abo ve named Court, this cause came on for further hearing upon the report of the Commissioners heretofore appointed by the Court in this cause on the 5th, day of April 1909, to make partition of the real estate described in the Plaintiff's petition, according to and in conformity with the provisions and directions of a decree of this Court made and entered in this cause on the 5th, day of April 1909; the plaintiff appearing by P. L. Thurman, his attorney, and the defendant, Alice Jack, app-aring by her attorneys, Abbott & Brown, and Mary Fox, Henry Fox, Ada Fox and Katie Fox appearing by their attorney and guardian ad litem, C. W. Gormly, thereupon the report of the commissioners, ap pointed to make partition of the land described in the petition herein, was taken up and considered by the Court.

And the Court after hearing the report of said Commissioners and being fully advised in the premises does find, that the said commissioners E. O. Carter, S. DeZell Hawley and J. L. Palmer, heretofore appointed by the Court to make partition of the lands described in plaintiff's petition between the plaintiff and the defendants herein, has made partititon of the said land, the same being the allotment of Nathaniel Brown, deceased, in accodenace with the terms, provisions and directions of the decree of this court heretofore made and entered on the 5th day of April 1909. And the Court does here and now approve, ratify and confirm the partition of said lands, as made and set out by the report of the Commissioners and its recommendations filed herein on the 7th, day of April 1909.

It is further found by the Court that due and legal service was had upon all of the defendants named herein, and upon luke Fox as the legal gauradian of the minor defendants Henry Fox, Mary Fox, Ada Fox and Katie Fox, and that after due and legal service was had upon said minors, C. W. Gormly, an attorney at law, was appointed by the Court as guardian as litem th defend for the above named minors.

It is further by the Court considered, ordered and adjudged that of the said lands described in the plaintiff's petition herein there be and is hereby partitioned, awarded and set apart to the plaintiff, Grant R. McCullough, a two fifths interest in said land, as his full, just, fair a d equitable portion thereof the following described lands, to-wit:

The Southeast Quarter of the Sputhwest Quarter of Section Ten (10) in Township Nineteen (19) North, of Range Twelve (12) East of the Indian Meridian, except the right of way of the Arkansas Valley & Western Railway Co., over and across said land, containing after exceptions 37 acres, more or less.
