

RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, On the 24th, day of April 1905, Frank C. Boles and his wife executed and delivered unto J. Cress, now deceased, their certain mortgage, on the hereinafter described real estate, to secure the payment of one certain promissory note of even date herewith, for the sum of \$800.00, and,

WHEREAS, the said note was paid in full to the said J. Cress, during his life time, and the said mortgage, was by the said J. Cress released by the execution of a release thereof by the said J. Cress, and

WHEREAS, the said release of mortgage so made by the said J. Cress, has been lost or misplaced and the said mortgage has never been released of record, and/

WHEREAS, the said J. Cress died on the 19 day of April 1907 and his estate has been administered upon by George F. Cress, as administrator, and said estate settled up in full and said administrator discharged as shown by a certified copy of the Order of Discharge, hereto attached and made a part of this release.

NOW, THEREFORE, we, George F. Cress, Julia Cress (widow of said J. Cress, deceased) Cora A. Smith, Edna M. Lowe, Flora B. Knowles, Thomas J. Cress and Laura E. Bishop, shown by said order of discharge, attached hereto, to be the sole and only heirs of said J. Cress deceased, do hereby acknowledge full payment and complete satisfaction of that certain mortgage given by Frank C. Boles and Matilda Bowles, his wife, to said J. Cress (now deceased) to secure the payment of the sum of \$800.00 dated the 24th, day of April 1905, and filed for record on the 1st, day of May 1905, and recorded in Book 19 at page 220 in the office of the Deputy Clerk of the United States Court, and Ex-Officio Recorder, at Wagoner, Indian Territory; the property hereby discharged and released from said mortgage lien is described as follows:

Lot Number Three (3) in Block Numbered Fifty Six (56) in the Town of Broken Arrow, Tulsa County, State of Oklahoma, (formerly in the Indian Territory?)

And we the signers hereto, do hereby state and covenant that we, the above named heirs, are the sole heirs at law of the said J. Cress, deceased.
