IN THE MATTER OF THE ALIENATION OF THE ALIOTMENT OF THOMAS ADAMS AND MOLEYAR HARJO, DEC/

ORDER.

Now, on this 18th, day of May 1909, this matter came on to be heard upon the petition of Charles Page, praying for an order of this Court, approving a certain deed of conveyance by one Samuel C. Adams, executed and delivered to this petitioner, and the petitioner appearing in person and by his attorneys Abbott & Brown and the said Samuel C. Adams, appearing in person, and the Court having heard the testimony and being fully advised in the premises, finds:

That the allegations in said petition contained are true; that the said Samuel C. Adams is a full-blood Creek Indian, duly enrolled as such and that there was allotted to him the following described land, situate in what is now Tulsa County, to-wit:

The Southwest Quarter of Section Twelve, Township Nineteen North, Range Eleven East.

And that the said Thomas Adams died on or about the 7th, day of March 1901, while a resident of and in what is now Tulsa County, Oklahoma, intestate and seized of the lands above described, leaving surviving him as his only heirs at law the said Samuel C. Adams, a brother and one Salina Fife, nee Harjo, and that said Thomas Adams had no children born to him after the 4th, day of March 1906.

The Court further finds that the said Moleyar Harjo, deceased, was a full blood Creek Indian, duly enrolled as such and that there was allotted to her as her distributive share of the lands of the Creek Nation, the following described lands situate in what is now Tulsa County, State of Oklahoma, to-wit:

The West Half of the Northwest Quarter of Section Twelve and the North Half of the Northeast Quarter of Section Fourteen, all in Township Nineteen North, Range Eleven East And that the said Moleyar Harjo, deceased, died on or about the 26th, dy of February 1907 while a resident of and in what is now Tulsa County, Oklahoma, intestate and seized of the lands last above described, leaving surviving her as her only heirs at law, the said Samuel C. Adams and Salina Fife, nee Harjo, and that said Moleyar Harjo Harjo, deceased, had no children born to her since the 4th, dayof March 1906.

The Court further finds that on the 18th, day of May 1909, said Samuel C. Adams as an heir at law of said Thomas Adams, deceased and as an heir at law of the said Moleyar Harjo, deceased, made/executed and delivered unto the petitioner, Charles Page a deed of conveyance, thereby conveying to the said Charles Page all his right, title and interest in and to thelands above described, and all of thelands, in consideration of the sum of of Thirty Four Hundred Ninety Dollars, which consideration the court finds was actually received by the said Samuel C. Adams, and same is adequate and reasonable and which said deed has been exhibited to and examined by the Court.

WHEREFORE, is is by the Court, condidered, ordered, adjudged and decreed that the said deed of conveyance be and the same is by the court in all respects approved and confirmed, according to Section 9 of an Act of Congress approved May 27th, 1908, entitled "An act for the removal of restrictions from a part of the lands of the allottees of the Five Civilized Tribes and for other purposes."
