Moghis, and their heirs and assigns forever, against the lawful claims and demands of all persons, whomsoever.

And I, Clara Twist, of Lowery, Indian Territory, wife of the said John W. Twist, for and in consideration of the aforesaid sum of money, do hereby release and relinquish unto the said party of the second part all my tight of dower and homestead in and to the lands and premises herein sold and conveyed.
