Lots One (1) Four (4) & Five (5) in Block Thirteen (13). in the original town of Skiatook, Oklahoma, according to the recorded plat thereof, together with the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining, subject to taxes of year 1909.

TO HAVE AND TO HOLD the same unto the said second party, his heirs and assigns,
forever.

And the said ~~parties of the first part~~ ^{parties} hereby covenant and agree with the said secondparty that at the execution and delivery hereof, the first parties are the owners of the above described premises, free and clear of any incumbrance whatever, and will forever warrant and defend the title to said real property in and to the second party, his heirs and assigns, against all claims or acts of the first parties and those of all persons claiming by, through or under them.

And I, Cora M. Aby, wife of the said Huletta F. Aby, do hereby release and relinquish unto Daniel Royse, all my rights of dower and homestead in and to saidlands.
