WHEREAS, the part of said town was approved by the Secretary of the Interior on the 10th, day of April, 1902, and was duly pakened on file; and,

WHEREAS, The said commission has appraised all of the town lots included in said plat at their true value, excluding improvements, which appraisal has been a proved by the Secretary of the Interior; and,

WHEREAS, the said commission has awarded the real estate described hereinbelow to Samuel F.
