Said driveway shall be used as a driveway by the parties to this agreement, their heirs and assigns and shall not be in any manner obstructed by either party hereto so as to interfere with the purposes and intention of this agreement.

This agreement shall be binding upon the parties hereto, their heirs and assigns, and shall continue in force and effect until the same shall be recinded in writing by the mutual consent of the parties hereto, their heirs and assigns.
