## RIGHT-OF-WAY GRANT.

IN CONSIDERATION OF TEN AND 50/100 Dollars, this day paid to John O. Mitchell, S. F. Jones & W. L. North, M. B. Also there is hereby granted the right to erect and maintain a telephone and telegraph line.
