Battershell, heirs and assigns forever, all the right, title and interest of the Muskogee Creek Nation aforesaid, in and to Lots Numbered 2 and 4,5, and 6 in Block numbered 10, in the Town of Bixby, Oklahoma, formerly Muskogee (Creek) Nation, Indian Territory, and according to the plat thereof on file as aforesaid.

IN WITNESS WHEREOF, I, the Principal Chief of the Muskogee (Creek) Nation, have hereunto set my hand and caused the Great Seal of said Nation to be affixed at the date hereinafter shown. Date January 15th, 1909.


