

A G R E E M E N T.

THIS AGREEMENT, Made and entered into this the 5th, day of July 1909, by and between the Ryan Oil and Gas Company, a corporation and the Frick-Ried Supply Company, a corporation.

WITNESSETH: THAT WHEREAS, the Ryan Oil and Gas Company, are the owners of an oil and gas lease, made and executed by James H. Thomas, as Guardian of Viola B. Thomas, George H. Thomas, Orville V. Thomas, Theron T. Thomas and Gladys M. Thomas, minors, and covers the following described lands to-wit:

The South Half of the Southwest Quarter of the Northeast Quarter of Section Twenty Four, Township 20 North, Range 12 East, in Tulsa County, Oklahoma, for a term of five years, from the 27th, day of May 1909.

AND WHEREAS the Ryan Oil and Gas Company desires to obtain Twenty Five Hundred Dollars worth of Oil and Gas well supplies from the said Frick-Ried Supply Co., has this day assigned the above oil and gas lease to the Frick-Ried Supply Co., as security for the payment of said sum of Twenty Five Hundred Dollars.

It is therefore agreed by and between both parties hereto that the Ryan Oil and Gas Co., agree to have the Pipe Line Co., to which the oil is sold from said lease, pay to Frick -Ried Supply Co., thirty one and $\frac{1}{4}$ per cent of the proceeds of the sales of all the oil produced and sold from said lease until the Frick-Ried Supply Co., have received the said sum of Twenty Five Hundred Dollars, or whatever sum may then be due to the Frick-Ried Supply Co., from the said Ryan Oil and Gas Company.

If said thirty one and $\frac{1}{4}$ of the proceeds of the sale of said oil as aforesaid does not amount to enough money to pay the said Frick-Ried Supply Co., the said amount of Twenty Five Hundred Dollars within six months from the date hereof, then the said assignment as above described shall become absolute owners of said above described lease to the extent of the amount still due from the Ryan Oil Company.

IN WITNESS WHEREOF, the Ryan Oil and Gas Company and the Frick-Ried Supply Co., have hereunto subscribed their names and attested the same with the seal of said corporation by their secretaries.
