ORDER CONFIRMING LEASE.

Now, on this 8th, day of August 1908, this matter came on for hearing upon the petition of the Guardian, Ben Grayson, for leave to lease the land of said Lula Grayson, a minor for oil and gas mining purposes, said land being within the County of Tulsa and State of Oklahoma, to-wit:

The Southwest Quarter of Section Twenty Four, Township Nineteen North, Range Thirteen East. and upon the report of the guardian representing that he had made and entered into an oil and gas mining lease with one E. M. Arnold, who had agreed to pay as bonus the sum of Forty Dollars, to pay one eighth of the oil produced and the sum of One Hundred Dollars per year for each gas well which might be brought in on said lease, and in the event no drilling was done on said land inside of one year, to pay a yearly rental of fifteen cents per acre cash.

And it appearing to the court that from the testimony of the Guardian, Ben Grayson, that he is the father of said minor Lula Grayson, and from the records of this court that said guardian is the duly appointed and qualified and acting guardian of the said minor; that said minor is a Creek Freedman and of the age of nine years.

And it further appearing from the evidence of said guardian that the said bonus offered is a fair and reasonable bonus and that one eighth of the oil to be produced is a fair and reasonable royalty and it further appearing from the testimony of John F. Hayden disinterested witness, that the said sum of \$40, is a fair and reasonable bonus for said lease and the Court being fully advised in the premises,

IT IS THEREFORE CONSIDERED, ORDERED AND ADJUDGED that the said lease executed by the
