WARRANTY DEED.

THIS INDENTURE, Made this 20th, day of May A. D. 1909, between Charles W. Brown and Jessie L. Brown, husband and wife, of the City of Tulsa, in Tulsa County, State of Oklahoma, parties of the first part and The United States of America, party of the Second part

WITNESSETH: That for and in consideration of the sum of Fourteen Thousand Eight Hundred Dollars (\$14,800.00), in hand paid by the United States of America unto the said parties of the first part, the receipt whereof is hereby acknowledged, said parties of the first part do by these presents give, grant, bargain, sell and convey unto the said United States of America, its successors and grantees, all of the following described real estate situated in the City of Tulsa, Tulsa County, State of Oklahoma, to-wit:

Brown and Jessie L. Brown will forever warrant and defend the title and possession of the same unto the said United States of America, against the said parties of the first part their heirs ar assigns, and all, each and every person whomsoever, lawfully claiming or to claim the same.
