ORDER APPROVING CONVEYANCE.

Now on this 13th, day of October 1908, the above matter coming on for hearing upon the petition of Caniyah Stop, asking for the approval of the conveyance from herself to Mossis F. Knight and Cyrus S. Avery, and witnesses having been examined in open Court, and the Court being fully advised in the premises finds:

That Caniyah Stop the petitioner is an adult Cherokee Full blood Indian, twenty eight years of age and fully capable of executing a deed to any lands which she acquired by inheritance upon the approval of this court.

That the said Caniyah<sup>Step</sup> is the only child and heir of Darkey Stop, deceased, who died on the 17th, day of November 1906, within the territory which is embraced within the limits of Adair County, Oklahoma.

That at the time of the death of Darryl Stop, she was the owner of the South Half of the Southeast Quarter of Section Ten, Township Twenty North, Range Thirteen East, in Tulsa County, Oklahoma, and containing Eighty acres.

And the Southwest Quarter of the Southwest Quarter of the Southwest Quarter of Section Twenty One, Township Fifteen North, Range Twenty Four East in Adair County, Oklahoma, and containing ten acres.

That the said Caniyah Stop has sold the above described land to Morris F. Knight and Cyrus S. Avery for the sum of Six Hundred and Sixty (660.00) Dollars.

That the court believes that it is for the best interest of Caniyah Stop that she sell said land and that the sum of Six Hundred and Sixty Dollars is a fair and reasonable price for said land.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that ~~that~~ the conveyance from Caniyah Stop to Morris F. Knight and Cyrus S. Avery of the above described land for the sum of Six Hundred and Sixty (660.00) Dollars be and the same is hereby confirmed and approved and declared valid.
