That the said Nancy Ellis is the same party to whom the Cherokee Nation allotted the Northwest Quarter ($\frac{1}{4}$) of the Southeast Quarter ($\frac{1}{4}$) and the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of Section Seven, Township Twenty One North, Range Thirteen (13) East, and said Weaver Ellis is the same party to whom was allotted by the Cherokee Nation the East Half ($\frac{1}{2}$) of the Southeast Quarter ($\frac{1}{4}$) Of Section Seven, Township Twenty One North, Range Thirteen East.

The Southeast Quarter of the Northeast Quarter and the Northeast Quarter of the Southeast Quarter of Section Twenty One (21), and the West Half of the Southwest Quarter of Section Twenty Two (22), Township Nineteen (19) North and Range Thirteen (13) East of the Indian Base and Meridian in the State of Oklahoma, and containing 160 acres, more or less. Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

TO HAVE AND TO HOLD THE ABOVE DESCRIBED PREMISES unto the said A. A. Viersen and George C. Beidleman, their heirs and assigns, so that neither the said Robert Fife, nor any person in his name and behalf shall or will hereafter claim or demand any right or title to the said premises or any part thereof, but they and every one of them shall by these presents be excluded and forever barred.
