And, Whereas, the collector of the revenue of said town of Skiatook, then known as the Tax Collector, did, on the 8th, day of April A. D. 1907, by virtue of the authority in him vested by law, at the sale begun and publicly held on the 8th, day of April A. D 1907, expose to public sale at the office of said Tax Collector in said town of Skiatook in substantial conformity with all the requirements of the statutes in such cases made and provided, the real property above described, for the payment of the taxes, penalties and costs then due and remaining unpaid on said property.
