QUIT CLAIM DEED WITH RELINQUISHMENT OF DOWER.

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Other valuable considerations and One and 00/100 Dollars, in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has demised, released, sold, conveyed and quitclaimed and by these presents does demise, release, sell and convey and quitclaim, unto the said party of the second part, all the right, title, interest, claim and demand which said party of the first part in and to the following described lot, piece or parcel of land or improvements situated in the Creek Nation, Indian Territory, Western District, and known and described as follows, to-wit:

The West Half of Lot Two (2) in Block Two (2) in Highlands Addition to the City of Muskogee, Ind. Ter., as shown by the recorded plat thereof.

Lot Nine (9) and Ten (10) in Block One (1) and Lots Fourteen, Fifteen and Sixteen in Block Two (2) in the Higgins Addition to the City of Muskogee, as shown by the plat filed in the office of the clerk of the United States Court, at Muskogee on the 4th, day of May 1904.
