RIGHT OF WAY GRANT.

This Indenture, executed in duplicate on this the 8 day of July 1909, by and between W. F. Applegeet, as guardian of the person and estate of Zelma F. Applegeet, a minor, a Creek Citizen and allottee of the following described lands, situated in the County of Tulsa, State of Oklahoma, to-wit:

No. 4 of SW. 4 Section 30 Township 17 Range 13. as party of the first part, and The Prairie Oil and cas Company, a corporation, created and existing under the laws of the State of Kansas, and duly authorized and engaged in the transportation of crude Petroleum through a system of pipe lines in the State of Oklahoma, as party of the second part.

WITNESSETH: THAT, WHEREAS, the said party of the first part did on the 8 day of July 1908, present to the County Court of Tulsa County in said State, a petition representing and showing that the said party of the second part is desirous of constructing a pipe line and a telegraph and telephone line over said premises, and that said party of the first part had received a proposition from said party of the second part for right of way for it's said pipe line and telegraph and telephone line over and across said premises the sum of Thirteen & 75/100 Dollars (\$13.75) being Twenty Five cents per rod, together with all damages which maght arise to crops or fences, and any other damages occasioned from the laying, maintaining and operating of said pipe line and telegraph and telephone lines.
