CONTRACT.

THIS CONTRACT, Made and entered into this 21 day of July 1909, by and between Clorie Grayson, of Mazie, Mayes County, Oklahoma, party of the first part, and J. Milton Turner, of St. Louis, Missouri, party of the second part, WITNESSETH:

THAT, WHEREAS, the said party of the first part has inherited the certain allotments of Garfield Colbert and Nancy Colbert, Creek Freedman, the said minors being the children of Louiza Colbert, a daughter of the party of the first part, said allotments consisting of the following described tract of land, to-wit:

North East Quarter ($\frac{1}{4}$) of the North East Quarter of Section 30; the South West Quarter ($\frac{1}{4}$) of the Northwest Quarter ($\frac{1}{4}$) and the South West Quarter ($\frac{1}{4}$) of the North East Quarter of Section 29-18-12, and the North West Quarter of the North East Quarter of Section 30, all in Township 18, Range Twelve (12), being the allotment of the said Garfield Colbert, and North East Quarter ($\frac{1}{4}$) of the North East Quarter ($\frac{1}{4}$), North West Quarter ($\frac{1}{4}$) of the North West Quarter ($\frac{1}{4}$) of the South East Quarter of the North East Quarter ($\frac{1}{4}$) of Section 31, Township 17, Range 12; North West Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$) of Section 17; East Half of South East Quarter of South East Quarter; North West Quarter of South East Quarter of South East Quarter; East Half of South West Quarter of South East Quarter of South East Quarter and North West Quarter of South West Quarter of South East Quarter of South East Quarter of Section 20, all in township 18 North, Range 12 East and Lot Two (2) of Section 31-17-12, being the allotment of Nancy Colbert aforesaid.

NOW, THEREFORE, for and in consideration of the sum of One Dollar, in hand paid by each party hereto to the other and the benefits and profits accruing to the parties hereto from a full and complete performance of the agreements and provisions hereinafter set forth, it is agreed by and between them as follows: to-wit:

The party of the first part hereby appoints the said party of the second part her true and lawful attorney for her and in her name, place and stead to sue for and recover for her the said party of the first part the title to the lands above described; hereby
