and that Gertie E. Winterringer should receive the sum of One Cent (\$0.0I) and that Sherman G. Pender should receive the sum of One Cent (\$0.0I) and that George E. Swain should receive the sum of One Cent (\$0.0I) and that Mary Swain should receive the sum of One Cent (\$0.0I), and that Grace L. Lynch should receive the sum of One Cent (\$0.0I) and that L. J. Smith should receive the sum of One Cent (\$0.0I), and that Lida B. Gwinnup should receive the sum of One Cent (\$0.0I), and that Rebecca Moran should receive the sum of One Cent (\$0.0I), and that Edmund Baden should receive the sum of One Cent (\$0.0I), and that City of Tulsa should receive the sum of One Cent (\$0.0I),

and that P. Porter, Chief of the Creek Nation should receive the sum of One Cent (\$0.01)

And it further appearing that said Missouri, Kansas and Oklahoma Railroad Company has deposited with the Clerk of the Court the said sum of One Hundred Dollars and Seventy Four Cents (\$100.74), in full of all compensation and damages determined by the said referees in favor of the said Creek Nation pr Tribe of Indians, P. Poster, Principal Chief of the Creek Nation or Tribe of Indians, the City of Tulsa, and the corporation and persons above named, and it further appearing that neither the said Creek sation or Tribe of Indians, and the said P? Porter, principal Chief of the Creek Nation or Tribe of Indians, the said City of Tulsa, nor any of the parties included in said waward has appeared from the award of the refrees herewin, within the time affixed in which such appeal might have been made; and all of which was done in accordance with the statute in such cases made and provided:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by this court, that the grounds sought to be appropriated by the said Missouri, Kandas and Oklahoma Railroad Company for the purposes aforesaid shall be and the same are hereby condemned to the use of the said Missouri, Kansas and Oklahoma Railroad Company, and that the same shall hereafter be subject to the occupation and possession of the said Railroad Company and the amount of One Hundred Dollars and Seventy Four Cents (\$100.74) assessed in favor of the Creek Nation or Tribe of Indians, P. Porter, principal Chief of the Creek Nation or Tribe of Indians, and the parties included in said award, shall be in full of all rights title and interest of said Nation or Tribe of Indians, said principal Chief of said Nation or Tribe of Indians, said City of Tulsa and of said parties included in said award in and to said ground.
