WITNESSETH: That said party of the first part in consideration of the sum of One & no/100 Dollars, to him duly paid, the receipt whereof is hereby acknowledged, has remised, released and quitclaimed, and by these presents does for himself, his heirs, executors and administrators, remise, release and forever quitclaim unto the said parties of the second part, and to their heirs and assigns, forever, all his right, title, interest, claim and demand both at law and in equity of, in and to all the following described real property and premises, situate in Tulsa County, State of Oklahoma, to-wit:

The East Half of the South East Quarter and the South West Quarter of the South East Quarter of Section Three (3), Township Nineteen (19) North and Range Thirteen (13) East of the Indian Base and Meridian, containing One Hundred Twenty Acres more or less, as the case may be, according to the United States Survey thereof.

This Quitclaim deed given to release the undivided one half interest of Alex Rogers in and to the above described lands which was deeded to Alex Rogers and J. M.
